Sirs,

As formally and unanimously decided during Imago Annual General Assembly in Delphi, on April 26<sup>th</sup>, Imago has withdrawn from the DRA project and the IMAGO declaration about DRA.

The name of DRA should, from now on, only be linked to the ACK or to the individuals if relevant, but the name of Imago cannot be used anymore in all communication, conferences, documents presenting the DRA.

All participants to the DRA project are not allowed to talk or present this project on behalf of IMAGO, because it is not an Imago project anymore.

We made it clear for all our members, it has been voted, it looks that you are not following the rules which could lead to major problems in the future relations between you as individuals, ACK and Imago.

The Imago Board is now the only official responsible on behalf of Imago, for communication, studies regarding archiving, preservation and relationship with authorities in that field.

We hope that this will make it definitively clear for you and for third parties, as this letter is going to be transferred to all institutions, people directly or indirectly involved previously in the conversations/ mailing regarding DRA.
